Dear Parents/Carers

Further to my letter of 19th June regarding the phased re-opening of all Rhondda Cynon Taf schools on 29th June.

As you will be aware, the Minister for Education in Wales, Kirsty Williams, announced on 3rd June 2020 that all children would have the opportunity to 'Check in, Catch up, Prepare' for the summer and September. The Minister highlighted that the summer term would be extended by one week, with the summer term ending on 27th July 2020, and that a two-week half-term break would be provided in the autumn 2020.

You may also be aware that last Friday, Welsh Government advised that it would be councils and schools across Wales that would have the final say on whether their schools would be available for the extra week of the summer term. Rhondda Cynon Taf Council have been working in partnership with our schools since this recent announcement to explore the opportunity of Rhondda Cynon Taf schools being open during the additional week of the summer term.

Despite the exceptional goodwill and professionalism that has been displayed by our schools and the willingness of staff to work this additional week, a number of factors have worked against our ability to progress with plans to open during this additional week and therefore, it is with regret that we announce that schools in Rhondda Cynon Taf will close on the 20th of July 2020, as originally intended. School based emergency childcare will cease on Friday the 17th of July 2020. Further information in relation to summer childcare will be released in due course.

We welcome correspondence in Welsh and corresponding with us in Welsh will not lead to a delay. Let us know your language choice if Welsh or bilingual.



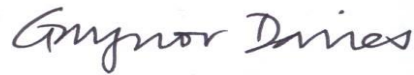
